RE: Preferred Drug List (PDL) Changes Postponed

The Pharmacy and Therapeutics (P&T) Committee of the Nevada Department of Health and Human Services' Division of Health Care Financing and Policy completed the annual review of the Preferred Drug List at their meeting held on June 21, 2007.

The Aug. 15, 2007, effective date for the following PDL changes has been postponed. As soon as it becomes available, the new effective date will be communicated to providers via the "Pharmacy Announcements" and "Preferred Drug List" webpages at https://medicaid.nv.gov.

- * For both Coreg® and Coreg CR®, prior authorization is not required if prescriber indicates an ICD-9-CM diagnosis code of 428 (heart failure) on the prescription **OR** if the recipient is concurrently receiving a diuretic with either an Angiotensin II Receptor Blocker (ARB) agent **or** an Angiotensin-Converting Enzyme (ACE) inhibitor.
