## **Nevada Medicaid Web Announcement 3024**

## Claims Submitted by Certain Provider Types for COVID-19 Vaccine and Administration Codes That Denied Have Been Reprocessed

Claims for the COVID-19 vaccine codes and vaccine administration codes listed in Tables 1 and 2 submitted by the provider types listed in Table 3 may have denied in error with one or more various error codes. The impacted claims have been reprocessed automatically.

Claims for the procedure codes in Table 1 had dates of service on or after June 17, 2022, through August 30, 2022.
