Attention Home and Community Based Services (HCBS) Providers:

Rate Survey Opens and Survey Training Sessions Scheduled

Attention provider types: **30** (Personal Care Services - Provider Agency), **39** (Adult Day Health Care), **48** (Home and Community Based Waiver for the Frail Elderly), **55** (Day and Residential Habilitation Services), **57** (Home and Community Based Waiver for the Frail Elderly in Residential Facilities for Groups), **58** (Home and Community Based Waiver for Persons with Physical Disabilities), **59** (Home and Community Based Waiver for the Frail Elderly in an Assisted Living Facility) and **83** (Personal Care Services - Intermediary Service Organization):

The Department of Health and Human Services, Division of Health Care Financing and Policy (DHCFP) is reviewing its current methodology for 1905(a) Personal Care Services (PCS), services under the 1915(c) Waiver for the Frail Elderly (FE) and Persons with Physical Disabilities (PD) waiver, and 1915(i) State Plan specific to Adult Day Health Care (ADHC), Day Habilitation, and Residential Habilitation services.

The DHCFP has contracted with Myers and Stauffer LLC, CPAs, to conduct a rate study. The Myers and Stauffer team has developed a cost survey for submission of provider data to provide accurate program and administrative cost information for the development of a rate methodology. The cost survey and instructions were made available for download as of **Monday, May 8, 2023**, at the following website:
