July, August and September 2014 Provider Training

The HP Enterprise Services (HPES) Provider Services Field Representatives will conduct several workshops for providers in the months of July, August and September.

- Quarterly Provider Training will provide the updates and changes that are occurring in Nevada Medicaid and Nevada Check Up.
- Introduction to Becoming a Nevada Medicaid Provider is offered for those interested in understanding what the Medicaid Program in Nevada entails and will focus on information, applications, public websites and general information. This course is for persons **not** already enrolled with Nevada Medicaid.
- **Claim Form Instructions** workshops will introduce the Nevada Medicaid paper form submission guidelines and are tailored to the completion of the specific form type used for your provider type.
- **Understanding Eligibility** will assist providers in understanding the eligibility screens for Medicaid recipients on the Provider Web Portal's prior authorization system.
- National Drug Code (NDC) Billing will review instructions for including NDC and NDC quantity on claim forms.
- Medicaid Services Manual (MSM) will introduce providers to the MSM.
- **Appeals and Special Batches** will help providers learn about the appeals process and required documents, and the updates to the special batching process.

Note: All courses are non-clinical in nature.
